# 4. **BUDGET & AFFILIATION FEES**

Cayte spoke about the 2020 Schedule of Fees which has a 2% rise in line with Consumer Price Index.

A question raised should the increase be 2% as the CPI is less than 2% - should we be in line with current CPI? It was noted that current CPI does not reflect the CPI on our expenses and that all industries are different. Why put the prices up if we are going well as the costs go to the clubs and their members? Hockey is expensive and we are in a competitive market place. Due to the nature of our sport we have costs that other sports do not have to bear. We need to replace the synthetic turf on AHC1 in the next twelve months so we need ensure adequate reserves. In 2021 we are looking to replace AHC2 synthetic turf and build a new clubhouse and change rooms for Albury in 2024. Note revenue is dependent on teams entered and games played which can change unexpectedly. Sponsorship of clubs is important and a change of the signage policy to allow use of tiles on the grandstands is to assist with this. Do we consider a major fundraiser – association wide?

The Schedule of Fees will be put on the web and sent out to the Clubs later in the week.

# 2 Senior Players:

a. Players eligible to compete in the Hockey Albury Wodonga Inc. State League Representative Team under Article 5.23.7 of these By-Laws and not deemed ineligible under Articles 5.23.7.1 or 5.23.7.2 shall be permitted to play in the Hockey Albury Wodonga State League Representative Team and other Hockey Albury Wodonga Representative Teams and Competitions for which they qualify subject to the limitations of Article 6 of these By-Laws.

# 5.23.7 General Eligibility:

To participate in the Hockey Albury Wodonga Inc. State League Representative Team a player must be a registered and financial member of a Hockey Albury Wodonga Inc. Member Club.

- 1 Junior Players:
- 1.1 Players eligible to compete in an Under-14 or lower age divisions of competitions conducted by HAW shall be ineligible to play in any Hockey Victoria Competition State League or other Senior Representative Team.
- 1.2 Players eligible to compete and/or actually competing in an Under-16 but not a lower age division of competition conducted by HAW shall be eligible to play in the State League Representative Team, the Under-16 competition conducted by HAW and the Senior Competition conducted by HAW subject to a resolution of a committee consisting of:
  - 1) The HAW Director of Representative Hockey
  - 2) The HAW Director of Athletic Development
  - 3) A Parent or Guardian approved Player Representative
- 2. Senior Players:
- Players eligible to compete in the Hockey Albury Wodonga Inc. State League Representative Team under Article 5.23.7 of these By-Laws and not deemed ineligible under Articles 5.23.7.1 or 5.23.7.2 shall be permitted to play in the Hockey Albury Wodonga State League Representative Team and other Hockey Albury Wodonga Representative Teams and Competitions for which they qualify subject to the limitations of Article 6 of these By-Laws.

#### Notice of Motion (D)

That the Hockey Albury Wodonga by-laws, Clause 5.23.2 be amended from

"A member of the association is permitted to have a dual club registration for the purposes of playing in the veteran's competition subject to by-law 5.23.1(a) and 5.23.1(b)." to read as follows as (a) & (b) do not exist

"A member of the association is permitted to have a dual club registration for the purposes of playing in the veteran's competition subject to by-law 5.23.1."



#### **Notice of Motion (E)**

That the Hockey Albury Wodonga by-laws, Clause 6.6.2.8 be amended from "An asterisk player shall not be awarded best and fairest votes." to read as follows "An asterisk player in the junior competition shall not be awarded best and fairest votes."

#### Notice of Motion (F)

That the following paragraphs be struck from the by-laws as they are no longer relevant "Final Three Rounds Eligibility

- 6.6.2.10 No player may play in any match in a lower division in the last three rounds if they have previously played six (6) non asterisk matches in a higher division for the same Club in the same season.
- 6.6.2.10.1 In exceptional circumstances Member Clubs may apply to the permits committee to determine player permits for situations they believe these By-Laws do not cover.

  (Note: In determining whether to grant such permits the factors to which the Permits committee shall have regard include:
  - 1 The division in which the player for whom the permit is sought is ranked or usually plays.
  - The division for which the permit is sought; and the reasons for which the permit is sought and whether such reasons that may be valid for a semi-final or preliminary final match will continue to be so for subsequent final matches.)"

President, Bert Eastoe was handed back the role as chair of the meeting.

# **GENERAL BUSINESS: (record of issues raised)**

The HV development funds that we received this year – what were they used for: The \$12,000 that we received from HV for Development was used for paying for the Roadshow program and its coaches, the Youth Development Program, courses for Coach and Umpire accreditation and the Junior Academy.

**Questions on Financial Statements:** Receivables - Member clubs income was down by \$15k. This was because clubs were are paid up compared to the same time last year. It was noted that the Canteen profit had gone down. Part of this was attributed to more games at Wodonga (also reflected in Competitions income), deferred games and the change of D3W draw. The canteen is run as a member service.

**Utilisation of the synthetic.** There was concern that there were vacant time slots on the synthetic particularly the Saturday afternoon games. Competitions advised that the structure is to have two or three weekends where all their teams play at home and for Wangaratta juniors to have a game every two weeks at home. Beechworth does not play seniors games at home. United had a lot more home games for their juniors due to field availability. The changes to the D3W rewrite caused some issues with the Saturday afternoon games, as did a number of deferrals in other senior games.

It was noted that with the completion of the drainage works that we will be able to play games on the grass fields at Albury and AHC3 and AHC4 will be as good as any grass ground available. The Albury grass grounds will not remove games from the out of town clubs.



**Bus hire for the Spitfires** why is the cost this year so much more. Cayte to investigate. It was noted that bus hire for 2015 was nearly double what we paid in 2018 due to better management of the bookings and one day hire.

Addendum: Investigation has revealed that we were overcharged on three bookings – so the cost should have been \$521.17 less. Hertz is in the process of crediting us with this amount. The rest of the increase between 2018 and 2019 was due to insurance of the driver in case of accident. The excess was previously \$6000. It was reduced to zero.

Do we bring our juniors in line with the HV age groups? This topic has been discussed numerous times and we will review again. There are pros and cons for both sides. A lack of interest in the older age group was the main reason it is as we have it now. If we have U13 then we also need an U11 as the gap is too large at that age. This year we only had six age permits for U17 to play in U16. Should we give it a chance with the four age groups? Clubs need to take it back their committees to see what their numbers are for next year. Its not just about the hockey – it's about playing with your peers. Perhaps have an U17's competition- perhaps an U18 for a permit. HAW will do some stats on the age groups and send them out to clubs. Alternatively we can look for a casual competition for Thursday nights as an alternate experience?

**Coaching clinic** – Do we need to run a coaching course this year – as a regional area we need to keep developing our coaches. Last year the numbers who turned up at the clinic were not high. Perhaps we need someone in to coach the coaches rather than run a L1 coaching course. We just had a course up here run by HV as assist us to coach juniors & the roadshow and a Community coaching Accreditation was achieved by those attending.

**Coaching** – Doug is going to concentrate on getting those who have done the courses accredited.

## Promotion & Media.

- **Newspaper:** We will try and get a higher profile in the newspaper noted that we are there three times a week during the season. It was noted that Don Cullen does an excellent job and the kids love seeing themselves in the paper. If you have a story that you need to let us know and we can send it to the media. Eg milestone games, families playing together etc
- Radio: Masters had success getting new members using 2AY this year. We need to invest more in getting on all radio stations.



• **Television** We need to invest in TV. It would be good if we could put an amount away in the budget for advertising and some TV to grow marketing in this area. We need to talk to an advertising agency. (Dutch media?). Paper is good but TV is much better. We need a catch cry (perhaps around family) as we are an Olympic sport and it is an Olympic year and we could sell that. The Board to consider commissioning and implementing a marketing plan to be run in January next year with a suggested budget of \$20,000. View it as an investment and if the timing is not right now then be ready for next year. James spoke about getting a three year plan —Or perhaps use a traineeship. Need to direct it to the outlying clubs to grow them and then worry about Albury/Wodonga.

#### **Notes of Thanks**

**Quorum**: It was mentioned that with the growth to the size of the Board that the quorum should increase – but it was recognised that it should stay the as is until we get a full board. Then it should go to half the Board plus one.
