1. OPENING

The President Bert Eastoe opened the meeting at 7pm. Bert explained how many votes were available to each club and each club nominated how they wished to vote (block or individuals)

3. MINUTES OF 2015 AGM

An overview of the 2015 AGM minutes was provided.

4. PRESIDENT & BOARD REPORTS

The President and Directors read out their reports. Bert Eastoe read out Competitions report in the absence of Deb Lawrence.

Resolved: That the director's reports as read be accepted

Moved Bert Eastoe / Andrew McMillan second - Carried.

5. **BUDGET & AFFILIATION FEES**

Michael Darmody presented the 2016 Financial report including Profit & Loss and Balance sheet. Questions included:

- Joanne Duffy wanted to know what the bad debts comprised.
 \$3000 of that debt was Armada which was no longer in business, the rest was a few schools who were well outside their yearly budget and some minor PY CL sponsors.
- Beth Simpson wanted noncurrent defined
 Noncurrent assets and liabilities are those that are outside the current 12 months
 (eg an amount of load to be paid but not in the current year)
- Glenn Delaney asked about Wodonga hockey ground what is our commitment.
 Board needs to consider the cycle of asset replacement and when the ground needs to be replaced in terms of ground life and other liabilities. Perhaps a new shock pad & turf. We will talk to WCC. \$375k for this option hoping for \$200k from WCC
- Bert Eastoe commented that this year we were six teams down in the competition which has a direct impact on the budget with both affiliation and game fees to about \$4000 per team
- Bert Eastoe noted that the wages bill has been halved with Operations part time and Enviro Culture contracted for maintenance



Kevin Mason asked about age of our turf
 Albury put in 2009, Wodonga was 1997. For a complete new turf it is approx \$450k
 Poly Turf came in a fortnight ago to advise on best options for our current turf and we await their report.

Resolved: That the Financial Report for 2016 be adopted.

Moved Michael Darmody / Glenn Delaney second - Carried.

The budget for 2017 was presented with a 2% rise in line with the CPA. The budget will be sent out to the Clubs later in the week.

Resolved: That the Affiliation Fees set for 2017 as recommended for the increase of 2% but removing the CRU adjustment to full affiliation fees as CRU have not had time to consider the implications for them. To be discussed/decided at a Special General Meeting to be held early 2017.

6. APPOINT AUDITOR

The Association accounts have been audited by Mr. Edwin Burkitt of Milham & Davis.

Resolved: That Milham & Davis be appointed the Associations Auditor for 2017.
