The Association has experienced significant success in the 2023 season, marking the completion of our second year in collaboration with Hockey ACT. This year has been very busy behind the scenes. The board and clubs have reviewed and discussed many of the current policies. This was done either to bring HAW in line with HACT, or as a direct result of a request from clubs or an incident.

The Board has been making great progress as it works towards finalising the Strategic Plan. The Board acknowledges however that the current business model continues to provide significant challenges as we look for ways to improve this moving into the future.

2023 also marked the passing of Mark Ball (a former Board Member) and Jim Williams Life member.

The commitment of HACT and HAW to the Engagement Officer position has been significant and is a stepping stone toward ensuring HAW has a sustainable and prosperous future. The vibe around the Road Shows, Gala days, U7's/U10's competition is an exciting development which continues to build. These are only a success because the clubs have embraced these programs as they recognise it is the way to future proof our sport. It's amazing to think that we provided over 5000 children a chance to experience hockey. Not all these children signed up this year, but we recognise that we may need to reach out to these communities 3 or 4 times before they sign up. The Engagement Officer was also able to run a coaching methods and technique session which was attended by clubs to help at club level and in the school programs. The school holiday clinic was run for the first time this year. It has limited success, but it gave us points to learn and build from.

At the onset of the season, we convened a meeting with the Presidents, Secretarys, Division 1 coaches, and willing captains to address the level and participation of umpires. We attempted to change the way the rostering was done but it was easy to slip back into old habits. After reviewing the By-Laws it is noted the umpire direct can/should have a sub-committee. We would like to ask the members if TWO(2) people would like to nominate to help our future umpire director with weekly scheduling. This would involve person ONE being responsible for the umpires draw for FRI and SUN games and

person TWO being responsible for SUN and MON games. This would allow the director more time to review games and hopefully the draw being released to clubs earlier.

To all our sponsors for continuing to support Hockey when it would have been so easy to say no, we truly value you and thank you. I thank these key stakeholders for their continued support of hockey as without them we would not be able to deliver the programs and services we currently enjoy. The Commercial Club need to be acknowledged for their continued support of our junior development which allows us to keep the costs for junior development and academy affordable for families, Platinum Signs, Screens and Media for their work with our scoreboard and signs, and All In Sport their weekly coverage of our games.

It was great to see our community engage with each other and inclusion offerings throughout the season. It was an incredible to introduction the Reconciliation Round for the first time. The community support for the Pride In Sport and Livin for Hockey Rounds showed what a truly welcoming, inclusive, and generous community we have at HAW. We recognise that 2023 was only a starting point of these rounds and would love to build on them each year. It has been suggested that the Special Events Director work with 2-3 clubs different clubs for each round to focus building an amazing event, rotating through the clubs. I also recognise that clubs have previously run similar programs and HAW could have consulted better with those clubs to respect the groundwork they have laid out before us.

Another event that changed its format significantly this year was the HAW Best and Fairest night. The format changed after long discussions with the clubs. It also saw the introduction of our team of the year. This was received with great success.

The Best and Fairest night was a wake call for all of us. Having our guest speaker Stephen Mowlam, and award recipient of 300 games Tony Donnolley reflect on their time in Spitfire's and the success of our Spitfire's, it highlighted that we are required to rebuild our pathways to Capital League and the want for our younger players to strive to play at this level. Our Spitfire teams struggled with low numbers, and moving forward we need to look at the current rules and permit system. It will also be important to develop a strategic pathway for a juniors to CL to make sure we have both the numbers and quality players required to compete at this level. It was wonderful to see the teams in the new uniforms that finally arrived very late in the season. Hopefully they will be of similar quality to our junior spitfire uniform, which looks like it is from the 1980s!

Throughout the Association we have seen the clubs celebrate significant events e.g., RUOK with Rachel Lynch, North celebrating 40 years, the first Falcons vs Wodonga ANZAC cup, Wodonga Hockey Club celebrating the opening of their club house, club days and the list goes on. This has been humbling to observe from the outside the individual clubs success this year.

HAW provided an opportunity for clubs to upskill on a first aid course, and early 2024 the opportunity for a coach's course. Wangaratta club also provided an opportunity to HAW for an introduction into umpiring course that well attended.

For the third consecutive president's report, it is highlighted that the Finance and Facilities Directors' position, aside from a three-month stint with Bert Eastoe this year, has remained vacant. This absence has led to a deficiency in procedural frameworks for future planning, resulting in the distribution of day-to-day responsibilities among multiple individuals. This situation is a cause for concern, and as previously mentioned, HAW may need to explore the option of outsourcing this crucial role.

Field 1 & 2 has required minimum maintenance this year. We received an upgrade to field 1 scoreboard that took users a little while to understand. CCTV has been installed in the office as a direct reaction to the break in December 22. The current club house required a switchboard upgrade to allow the external power points to work and the heaters within the clubhouse. More purple rubbish bins have been purchased for the cans/bottles. The new clubhouse upgrade continues to move forward, and we are in the process of applying for 2 grants to get the project funded. It was agreed that a whole complex approach should be considered when applying for the grants to include the replacement of field 2 which will be due soon and a review of the lighting system at field 1 and 2.

Field 3 has seen major changes for a second year in a row. We thank the clubs and players for their patience as we worked and continue to work through the teething problems. Wodonga Hockey Club (in particular Kyle and Vanessa) and Wodonga council need to be complimented on the outcome of both the new change room facilities and WHC pavilion. The association has been in contact with

Wodonga council in relation to the replacement of the lights that were installed in the late 1990. Under the lease conditions Under the current lease HAW is not allowed to upgrade the infrastructure, we are allowed to maintain. We are no longer able to maintain the aging lights as the globes are not sold anymore. We have come to an agreement with the council to finally have the water reconnected on the dugout side of the field. HAW is in the process of costing a new 10ft powered shipping container to install as a tech bench solution on the dugout side. This will contain the scoreboard controller, a freezer for ice and the HAW vests. As container is less than 10m2 it will not require a building permit only a local law permit making the process simpler.



At the 2022 AGM a \$25,000 allocation was made for participation and capital works. This has been allocated as follows:

Without your commitment, dedication and trust we would not be in a position to experience the participation growth of the past two seasons. You continue to remain incredibly positive and drivers of the game and for this cannot thank you enough.

My gratitude is extended to my fellow Board members and Operations Manager (both Cayte and Mark) for their unwavering dedication to the organisation and their steadfast commitment to maintaining focus. As volunteers, managing a complex business with full-time work commitments, we oversee various forms of competition, development programs, high-performance initiatives, commercial property, and extensive facility management. We are fortunate to have a Board with the requisite experience and skills to proficiently handle all facets of the business.

On a personal note, this has been a challenging year. I feel that my actions have been more reactive then proactive that goes against my nature.

Now that we have completed 12 months together, we all have a better understanding of what should occur in each month. It has highlighted that we need more structure for all directors' roles to be handed over with the best-informed transition possible. This is something that I feel was lacking in taking on this role. I apologies for the delay in providing this report. The directors received the Audited financials on Wednesday 15th at 4.00pm. Followed by a moved Board meeting on Thursday 16th (which I was unable to attend due to work commitments). This delay in receiving the audited reports has happen previously. The constitution requires the AGM is held in November, but this leaves very little time for the financials to be prepared and allow clubs time to review and digest them. Given the short time you have to review I am happy to take clear questions on notice and provide the answers back to all clubs.

Competitions

I start by thanking all current board members for their continued support regarding competitions and being active sounding boards when required.

Thank you also to Jo Duffy for her continued work with the permits committee. This really has become a streamlined process and your years of service to permits is not taken for granted. I note this year we had over 194 permits throughout the season and really want clubs to reduce their reliance on permit players to field sides. It highlights the need to streamline permits, hash, asterisk and over age permits system before 2024.

Season 2023 saw a full season completed, 900 games were scheduled over a total of 21 rounds for seniors and 18 rounds for juniors. With number of rounds for each division or age group below.

- Division 1 20 rounds plus finals
- Division 2 & 3 21 rounds plus finals
- Juniors saw 18 rounds despite the breaks incorporated around unaligned school holidays.

Thank you to our participation officer Maddy Poulton on a successful Under 7s, Under 10s and school program, hopefully continued growth will see all clubs benefit from this offering.

I thank all clubs for their participation, and flexibility when changes were required. There is always tweaking required throughout the season due to various issues that arise outside of our control.

It was great to see despite clubs varied sizes and team numbers, that all clubs were present in the first week of finals, with grand final weekend seeing 5 clubs still vying for at least 1 premiership.

With Hockey Australia's move in junior age groups from the start of 2024, we, as an association will offer what we can based on demands and needs of junior players, in the coming years.

Currently we see continued support from the hockey community embracing a twilight program with 21 teams in the open program on Tuesday nights and 5 boys and 9 girls' teams in the summer sixers program which is a first for this year. I thank Cayte Campbell and Maddy Poulton for the work they both did to get these programs offered this year.

Hockey Albury Wodonga will continue to evolve with the 2024 draw scheduling being outsourced for the first time, and review of competition final series and permits to occur prior to commencement, with goal of improving the hockey experience for all our players.

The 2024 Season Calendars will be distributed to clubs once all teams' nominations are received as club days are an important part of 2024 planning and further alignment with HACT regarding rounds of significance.

Congratulations to all our 2023 premiership teams, the hockey community conduct throughout the finals series topped off a great season.

2024 looks to see a stronger partnership development with HACT and I hope to be involved.

Junior Representative Hockey

This year was a busy year with teams attending HACT June LWE, NSW State Championships, and the Goulburn Carnivals. We also had several players representing ACT at National Championships.

I would like to congratulate all Junior representative players this year. The commitment to training was positive and they all participate in the carnivals and Championships with sportsmanship and were great ambassadors for HAW.

Canberra's June Long weekend was well attended by HAW, with us sending teams in Under 11's, under 13's and Under 15's Boys & Girls Teams. Under 13 Girls and Under 15 girls had strong participation levels with two teams competing. This is a great carnival to promote to more of our players next year as a taste of representative hockey and an opportunity to play against teams from other associations.

NSW State Championships were open to us again this year. There was initial interest in all age groups, however we were only able to send full teams to the Under 18 Boys, Under 15 Boys and Under 13 Girls State Championships. It was a very successful weekend for our first year in the NSW Under 18 Boys State Champs held in Wollongong. The team Won 2, Drew 1 and lost 1 to finish 3rd in Division 3. The Under 15 boys travelled to Wagga and came 4th in Division 3. The Under 13 Girls were our most successful team this year. They Won Div 4 at the Championships at the Central Coast. Looking forward to 2024 I would love to see our Junior Rep program place a greater focus on these Championships and endeavour to enter teams in all age groups. Distance to the venues and cost of travel for a three-day Championships is a major factor when planning for next year.

The Goulburn Hockey Association held 1-day Carnivals thought the year. We entered teams in all age groups, Under 11's, Under 13's and Under 15's Boys and Girls. The Under 18 carnival was cancelled at the last minute due to lack of interest. This carnival allowed many new players the opportunity to play outside our competition. Our Under 13 Boys and the Under 11 Girls were successful in winning their respective divisions.

I would like to thank HACT for their support and encouragement of our junior rep program. We initiated two programs this year to assist our ACT rep players. Dom Wild held coaching sessions for some of our U13/U15 so they didn't have to travel so much to Canberra and this month we are giving our players interested in trialling for U16/U21 teams the opportunity to train leading up to the trials. I would like to thank many of our senior Spitfire players for assisting with this training.

HAW we successful in attaining a grant for starting to replace our uniforms. Whilst our present uniforms are still in relatively good order, with the expansion of our rep program it is important we start to build on a replacement process into the future.

This year there were many new players, some new great young coaches and managers who helped contribute to a successful program this year. I would like to thank all of them for their time and energy and I appreciate all the support I received from them. I would like to thank Cayte for all her invaluable assistance in helping to get all our teams to their respective carnivals.


School Hockey Roadshows


The 2023 school hockey roadshow was extremely successful, Hockey Albury Wodonga delivered the roadshow to 26 schools. This included schools from Albury, Wodonga, Wahgunyah, Bethanga, Wangaratta, Walla, Chiltern, Holbrook and everything in between.

Our coaches delivered a great introductory program to 5193 students, which is a fantastic achievement for the association. In comparison to 2022, this figure was over 42% increase in the number of individual participants we delivered the program to.

It was also noted that the local Riverina trials, specifically the boy's team, had a much higher attendance than they have had in many years. Organisers credited this to the work being done in the schools with hockey.


The charts below display a comparison of the numbers from 2022 to 2023.

Come & Try Day's

Our Come & Try Day's were a huge success in Albury, Wangaratta, Wodonga and Corowa. The teams worked well together in putting on a great taster of hockey at each location, which attracted many new sign ups on the day.

U7's & U10's Program

Our Under 7's & Under 10's program was revamped this year to assist with the development and transition of players to the U12's competition.

As such, we implemented a modified version of rules into the U10's age group and engaged some of our junior members to assist with umpiring the games.


This allowed our juniors to develop confidence, positioning and whistle tone techniques in a safe and fun environment. At the end of the program, we had 12 junior umpires umpiring our U10's program.

Round robin style carnivals were held in each of the 4 locations – Albury, Wodonga, Corowa and Wangaratta. All the clubs worked in collaboration to put on some great activities for kids. Each carnival had at least 80% of our registered children attend.

Our bring a friend day saw the addition of a donut van to the grounds, what a roaring success this was! The day attracted many new players to hockey, with several children signing up for the remainder of the season and keen to continue in 2024.

The end of season celebration was well attended with all the children receiving their medal and Chill membership packs.

The graph below indicates the increase in registrations of U7's and U10's participants from 2022 to 2023. The overall increase in this registration category is over 38%.



Primary Schools Gala Day

After many years of Hockey Albury Wodonga not offering a Primary schools gala day to our local region, this year we put the offer out there to gauge the interest from schools.

The day was a resounding success with 25 teams and over 325 children participating. The huge numbers meant we needed to activate the two grass fields in Albury to create 4 playing fields for the day.

We had great support from some of the local high schools, who allowed their students to attend the day and assist with umpiring.

Small Schools Gala Day

Some of our small schools in the region also had a hockey gala day at the Albury Hockey Fields. There were 5 schools in attendance – Upper Sandy Creek, Mitta Mitta, Talgarno, Bethanga and Eskdale who each bought their whole school to the gala day. Though it was a hot day, the 120 students who attended had a great day learning new skills and playing games. Again, the support and expertise from our local coaches and high school students made the day possible.

Sporting Schools Australia Program

There were 5 schools who applied for a grant through Sporting School Australia to have a hockey program delivered in their school. Some of these schools also opted to purchase some hockey gear with their funding.

Summer Sixers

In an effort to increase the membership in the U14's age group in the off season, Summer Sixers was developed. The new program was a 6 a side competition played on half a field. The teams played modified rules to ensure the safety of new players. The program attracted 8 girl's teams and 5 boy's teams, who played a 5-week round robin style program. The development of this program acquired 15 new registrations in the U14's age category.

Open Twilight

Our annual open twilight competition is a mixed social program played on a full field with modified rules and no scores or ladders kept. This year, we had a record 22 teams register to play, triggering 4 time slots and the use of HAW Ground 3 to accommodate the high number of registrations. There have been an additional 25 new members post season to register for twilight. The twilight season will continue until mid-December.


Coaches

We have a pool of 30 coaches who have assisted in the delivery of all our programs in 2023 including Come & Try, U7/U10 program, school roadshows, sporting schools Australia programs, gala days and many more. Overall Participation

HAW overall participation including all categories of registration has increased 15.4% based on data collected over the last 12 months (August 2022 – August 2023).

Notes to the Financial Reports

1. Statement of Significant Accounting Policies

The significant accounting policies which have been adopted in the preparation of these financial statements are:

(a) Basis of Preparation

The financial report is a special purpose financial report which has been prepared in accordance with the Accounting Standards, Urgent Issues Group Consensus Views, other authoritative pronouncements of the Australian Accounting Standards Board and the Associations Incorporations Act 209 of (NSW) and the Associations Incorporation Reform Act 2012 of (VIC).

They have been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. The accounting policies have been consistently applied.

- (b) Depreciation / Amortisation of Property, Plant and Equipment Items of property, plant and equipment including leasehold improvements are depreciated/amortised over their estimated useful lives from the date of acquisition using the straight –line method at rates ranging between 5% and 50%.
- (c) Inventory Inventories are carried at the lower of cost and net realizable value. Cost is based on the first in, first out principle.
 - (d) Income Tax

The income tax laws exempt sporting clubs from the liability of income tax.

(e) Goods and Services Tax

Revenues, expenses and assets recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognized as part of the cost of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the Statement of Financial Position.

Cash Flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.
