Once received, the Association or Club Nominated Supervisor or Person in Authority must inform the Team Coach and/or Team Manager of the Transportation/Pick Up Approval in a timely manner and in any case before the first transportation or pick up occurs as set out in this document.

Where it is not possible for a parent/guardian to provide this form in advance, the parent/guardian should send a text message and/or email to the Team Coach, Team Manager and the Association or Club Nominated Supervisor or Person in Authority providing such approval and undertaking to provide this signed form in a timely manner and in any case prior to transportation occurring. This approval should be documented by the Association or Club Nominated Supervisor or Person in Authority and any text messages should be retained by the recipient in a safe place for future reference.

By signing this form, any person assigned to transport a child agrees that they must always drive responsibly, not be impaired by alcohol or any other mind-altering substances, have an unrestricted drivers' licence and to the extent practicable, not be alone in the car with a Child. Children may only be transported in a vehicle when the manufacturer stated capacity is adhered to and seatbelts and child restraints must meet Australian Standards (AS/NZS1754).
