# NOTICE OF RACE

# **Organising Authority:**

Adelaide Sailing Club Inc

The notation '[DP]' in a rule in the NoR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

#### 1. Rules

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Australian Sailing Prescriptions and Special Regulations Part 2 Off the Beach Boats will apply. It will be the responsibility of all competitors to ensure that personal flotation devices comply with a standard equivalent to those listed in Special Regulations 5.01 Personal Flotation Devices, are maintained and in good condition.
- 1.3 The class rules of the respective classes shall apply.
- 1.4 RRS 44.1 is changed so that the Two Turns Penalty is replaced by the One Turn Penalty.
- 1.5 Any amendments to this Notice of Race will be posted on the event website prior to 6st April 2019.

### 2. Eligibility and Entry

- 2.1. The regatta is open to all junior sailors (under 18 years of age). All competitors must be at least a member of a yacht club affiliated with Australian Sailing.
- 2.2. Eligible boats may enter by completing the online registration by 7<sup>th</sup> April 2019. Entry is Free.

### 3. Schedule

- 3.1 As many races as possible are scheduled.
- 3.2 There will be no warning signal made after 1530 hrs on Sunday 7<sup>th</sup> April 2019.

#### 4. Sailing Instructions

The Sailing Instructions will be available at Registration and may be posted on the regatta website

#### 5. Venue

- 5.1 The regatta location is the Patawalonga Lake on Eastern side, North of the King Street Bridge.
- 5.2 Attachment 2 shows the approximate location of the racing area.

#### 6. Courses

- 6.1 The courses will be as described in the Sailing Instructions and at the Briefing.
- 6.2 Courses may be varied by verbal instruction and posting on the Notice Board.

#### 7. Penalty System

- 7.1 Appendix T, Arbitration may apply, except as changed by NoR 7.2
- 7.2 T1 (b) 30% Scoring Penalty is changed to 20% Scoring Penalty.

# 8. Scoring

- 8.1 The regatta will consist of as many races as possible races of which two races must be completed to constitute a regatta.
- 8.2 The number of races to count will be as follows:
  - (a) When fewer than five races have been completed, a boat's series score will be the total of her race scores.
  - (b) When from five to seven races have been completed a boat's series score will be the total of her race scores excluding her worst score.
  - (c) When eight or more races have been completed a boat's series score will be the total of her race scores excluding her worst two scores.

# 9. Safety.

- 9.1 Attention is drawn to Rule 1.2 and Rule 4
- 9.2 Discretionary penalties will apply to Rule 41 Outside Help. Actions by the Race Committee in retrieving crews and returning them to their boats may not be penalised. Actions by a Coach nominated by the Organising Committee will not be penalised.

## 10. Support Boats

13.1 Coach and support boats are not permitted on the Patawalonga Lake.

#### 11. Media

- 11.1 In submitting the entry form, all competitors, parents, legal guardians and custodians provide their permission for all photographs, video, TV and sound recordings to be the property of the organisers and used for any purpose including public viewing and posting on the event website.

### 12. Prizes

12.1. The following prizes will be awarded;

Opti Cup – Optimist

Bic Cup - Open Bic

Tillett Trophy - International Cadet

Petersen Trophy – Other classes on Yardstick

12.2. Other prizes may be awarded at the discretion of the Organising Authority.

#### 13. Radio Communication

13.1 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication. [DP]

#### 14. Insurance

- 14.1 All boats competing in the Fisher Petersen Tillett Regatta shall be insured with third party liability insurance with a minimum cover of AUS\$5,000,000 per incident.
- 14.2 All competitors who submit the Entry Form are deemed to have made a declaration that they hold such cover.

#### 15. Disclaimer

- 15.1 It is the competitor's decision to enter an Event or to start and continue in any race. Competitors shall accept that their participation in an Event is at their exclusive risk in every respect. See Racing Rule 4, *Decision to Race*.
- 15.2 None of the Organising Authority, their officers, members, volunteers, servants or agents accept any responsibility whatsoever in respect of loss of life, personal injury or damage to property which may be sustained by reason of their participation or intended participation in this event or howsoever arising in connection with the event.
