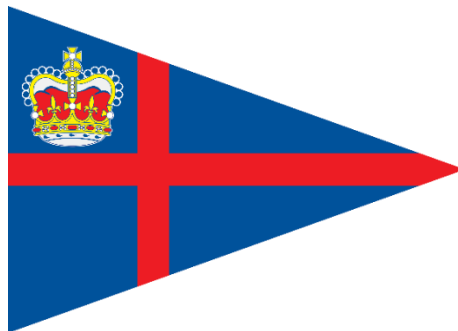




PITTWATER SECONDARY SCHOOLS TEAMS RACING REGATTA

5 & 6 March 2021

NOTICE OF RACE



Royal Prince Alfred Yacht Club

The Organising Authority (OA) of the 2021 Pittwater Secondary Schools Teams Racing Regatta is Royal Prince Alfred Yacht Club, 16 Mitala St, Newport 2106.

1. RULES

- 1.1 The 2021 Pittwater Secondary Schools Teams Racing Regatta will be governed by the rules as defined in the World Sailing (WS) *Racing Rules of Sailing* (RRS) including [Appendix D – Team Racing Rules and Appendix J Addendum B – Boats provided by the Organising Authority](#).
- 1.2 The Special Regulations of Australian Sailing (AS) Part 2; 5 Personal Equipment will apply.
- 1.3 Race Signal AP is amended so that the Warning Signal shall be made not less than 30 minutes after “AP” is lowered ashore.
- 1.4 The Race Committee shall only be represented by the Race Officer or their nominated representative.
- 1.5 The Protest Committee shall only be represented by the Protest Committee Chairman or their nominated representative.
- 1.6 Rule 66 is amended so that on the last race day of the Series, a request to re- open a hearing shall be made within the protest time limit or within 30 minutes of being informed of the decision, whichever is the latest.
- 1.7 Pacer Class rules will not apply.

2. ADVERTISING

Advertising will be in accordance with WS Regulation 20. The Organising Authority reserves the absolute right to require any competitor to remove any material from their boat, equipment or clothing which may be in contravention of moral decency or competitive to any event sponsor. There will be no request for redress to any such ruling.

3. ELIGIBILITY AND ENTRY

- 3.1 A team shall consist of a minimum of six and maximum of eight members and any combination of six team members may compete in any race.
- 3.2 All members of a team shall be either:
 - 3.2.1 All bona fide students from one secondary school (School Team); or
 - 3.2.2 All bona fide students from no more than two secondary schools (Composite Team).
- 3.3 All team members shall be less than 19 years of age as at 31 December 2021.
- 3.4 All competitors shall be fully paid members of an Australian Sailing Affiliated Club.
- 3.5 Eligible teams shall enter by submitting the application form together with payment via this link: <https://www.revolutionise.com.au/trpayachtclub/eventsregister/90665/>
- 3.6 The entry fee is **\$420** per team including GST.
- 3.7 A damage deposit is applicable for each team and is **\$600** which may be accepted in the form of a signed credit card authorisation at registration. This applies to all teams.
- 3.8 **Entries close at 5pm Friday 26th February 2021.** Late entries may be accepted at the discretion of the OA and a late entry fee of an additional \$100 will be payable for any late entries accepted.
- 3.9 The Organising Authority is targeting 12 teams. Priority will be given to teams training at the Royal Prince Alfred Yacht Club. Acceptance of teams will be based on order of registration. Where schools enter more than 2 teams, the acceptance of additional teams from that school will be at the discretion of the OA.

5. VOLUNTEERING AND COMPULSORY DUTIES

- 5.1 Each team must provide a minimum of two volunteers to assist with race management.
- 5.2 Each Team must supply a senior sailor with a strong understanding of the [racing rules of sailing](#) to umpire for the duration of the event.

6. SAILING INSTRUCTIONS

Sailing Instructions will be available to entrants at the Sailing Office of the Royal Prince Alfred Yacht Club or from the RPAYC website by Wednesday 3rd March 2021.

7. VENUE AND RACING AREA

- 7.1 Royal Prince Alfred Yacht Club (RPAYC) is located at 16 Mitala St, Newport, NSW 2106.
- 7.2 Racing will take place in the waters north, or south east, of Scotland Island, this is subject to change depending on conditions at the discretion of the OA.

8. THE COURSE

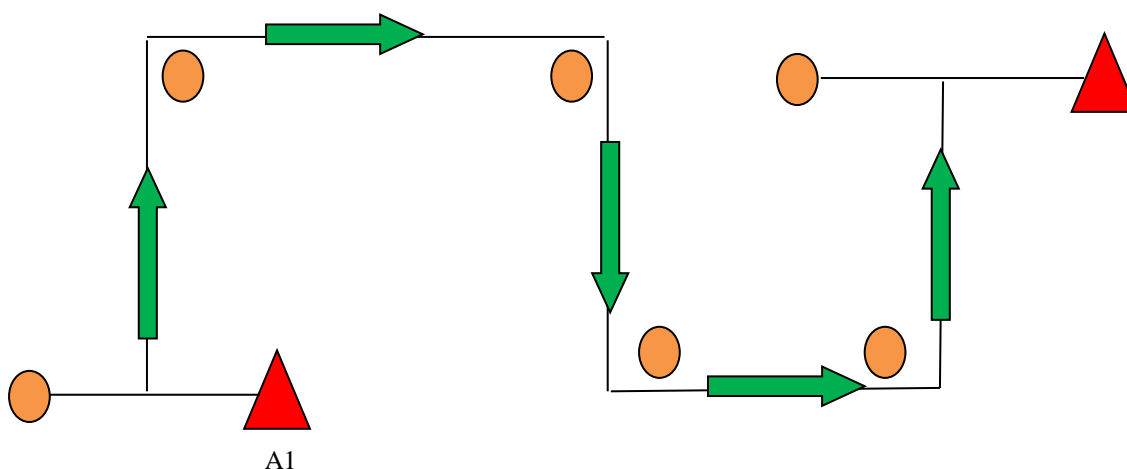


Figure 1 – Starboard Digital N course

- 8.1 The course to be sailed will be a starboard digital N course, as depicted in figure 1 below.

9. RISK WARNING

This Risk Warning is issued, pursuant to the Civil Liability Act 2002, to all persons wishing to participate in the sailing activities conducted by The Royal Prince Alfred Yacht Club.

Participants are warned that, regardless of the precautions, which might be taken by reasonable and experienced persons, sailing can be a dangerous pursuit and participants are exposed to significant risk of property damage, physical harm and possibly death.

As an indication, these risks may include, but are not limited to:

- The extremes of weather and sea conditions.
- The potential that control of vessels may be lost, resulting in collision with objects and other vessels.
- The sudden movement of the vessel at any time and the possibility that participants may fall or be thrown overboard, resulting in drowning.
- The possibility that participants may be injured by equipment on the vessel.
- The absence of immediate medical care and the likelihood that significant delays may occur before medical care is available.
- Exposure to the elements for extended periods.
- The possible presence of dangerous marine life.

The Organising Authority also warns participants that regardless of their best intentions, they may be unable to render assistance to participants who are in distress. Participants are warned to consider the above risks and all other risks before deciding to participate in any sailing event with the Royal Prince Alfred Yacht Club.

10. DISCLAIMER OF LIABILITY

Competitors participate in the Series and its component Regattas entirely at their own risk. See rule 3, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the Series.

11. COVID 19 REGULATIONS

A reminder to maintain proper social distancing as per the current NSW Government regulations (subject to change).

Participants in the regatta are expected to comply with COVID-19 Safe Practices, and follow all directions of COVID marshals, while present on the premises of the Royal Prince Alfred Yacht Club.

Competitors, volunteers, staff and spectators are required to sign into the RPAYC premise via the displayed Service NSW QR Code / App.

Participants are not to compete, or be present on club premises, if showing symptoms of COVID-19 and should seek a test. Symptoms include fever, dry cough, sore throat, shortness of breath, runny nose, loss of taster and/or loss of taste.
